## **Wisconsin Crop Innovation Center Completes PBIMP Audit**

The <u>Wisconsin Crop Innovation Center</u> (WCIC), an administrative unit of the College of Agricultural and Life Sciences at the University of Wisconsin-Madison, has successfully completed its Plant Breeding Innovation Management Program (PBIMP) audit.

WCIC is the second organization to complete a PBIMP audit and the first academic organization to do so. WCIC provides plant transformation and editing services in a wide range of species (specializing in elite varieties), for clients and collaborators all over the world. The Production Team currently focuses on the weekly transformation of maize, soybean, sorghum, cowpea, and hemp. The R&D Team has successfully transformed many legumes and other important crops, including seven of the top ten crops ranked by annual global production, and can accommodate additional crop

transformations upon request.

### **GSG Presents to Genome Editing Workshop**

Earlier this month, the Global Stewardship Group presented to, "Precision, Policy, and People: A Genome Editing Workshop for Crop Improvement" at the invitation of the International Rice Research Institute and the Thailand Rice Science Institute. GSG staff presented virtually to the event held in Bangkok, Thailand.

The goal of the workshop was to discuss the potential of innovative genome editing technologies and their potential in agriculture, such as climate change, food insecurity, and emerging crop disease challenges, as well as share the regulatory environment in Asia. GSG's presentation included information on its programs, such as the <a href="Plant Breeding Innovation Management Program">Plant Breeding Innovation Management Program</a>, Quality Management Systems, Incident Response, and Third-Party Management.
